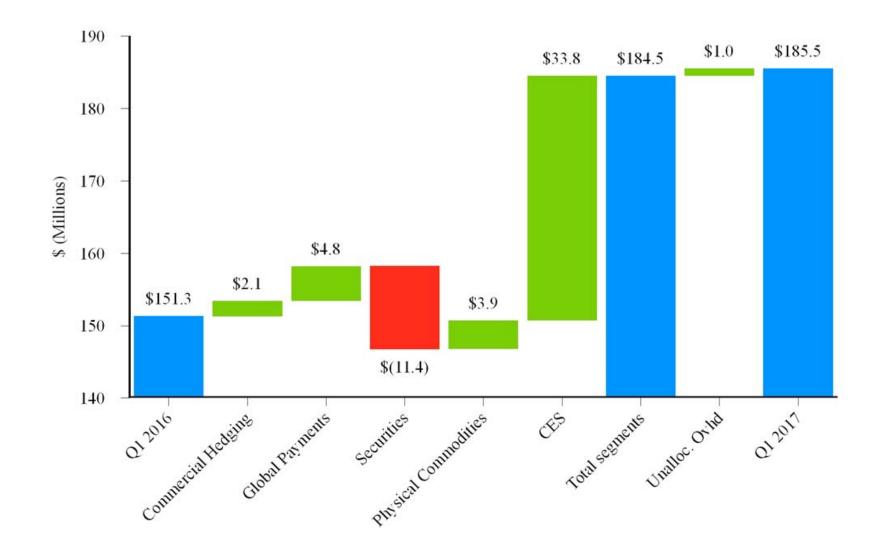

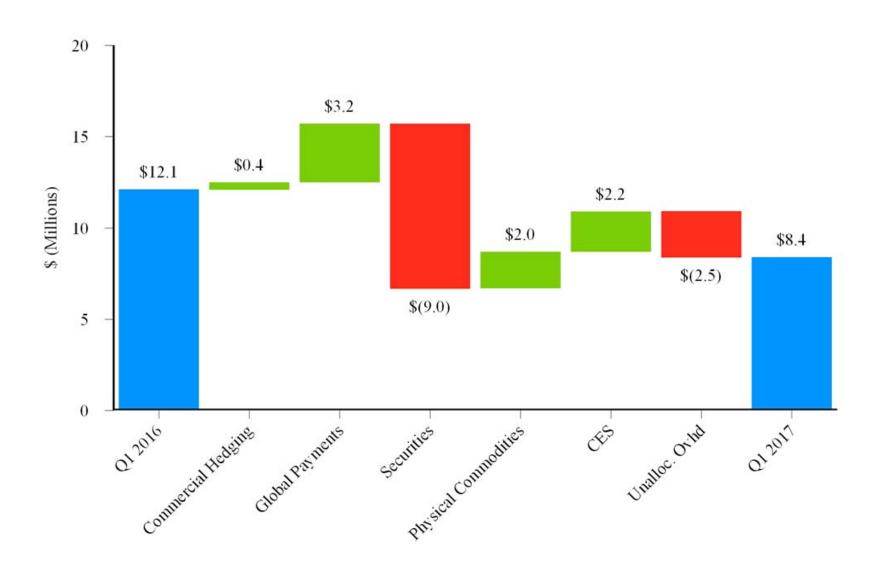
Changes in Operating Revenues by Segment Q1 2017 Compared to Q1 2016

Changes in Segment Income by Segment Q1 2017 Compared to Q1 2016

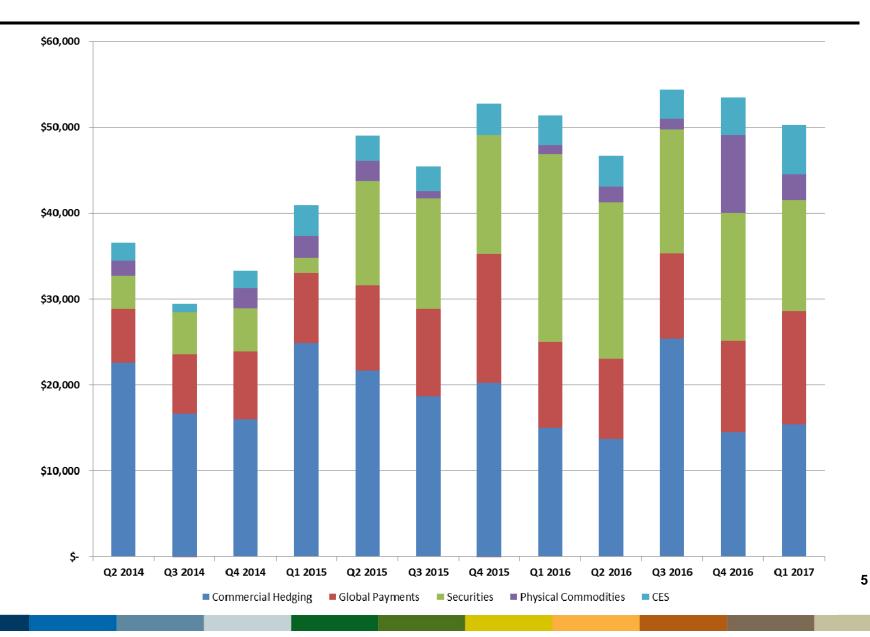

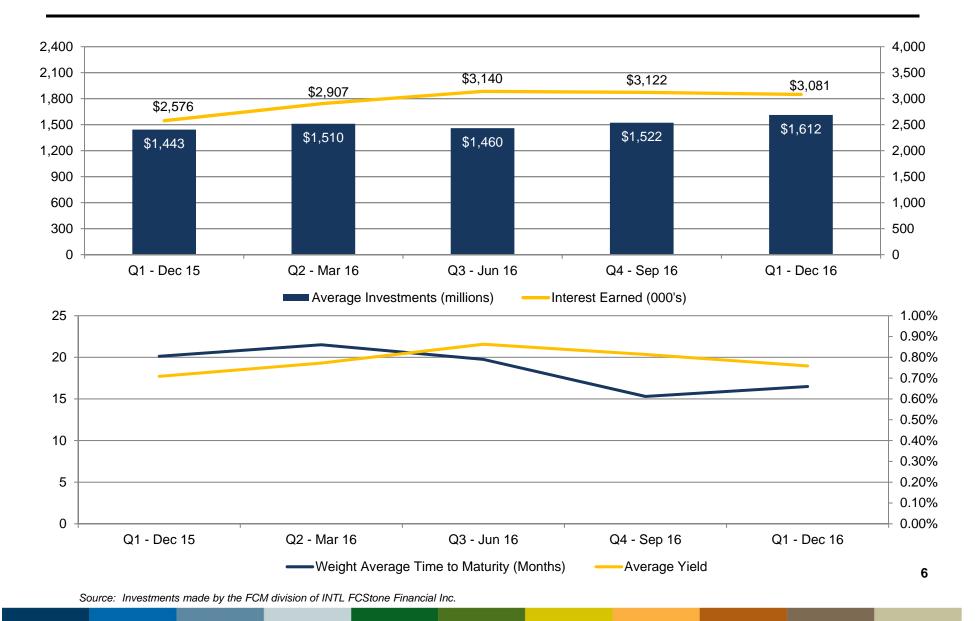

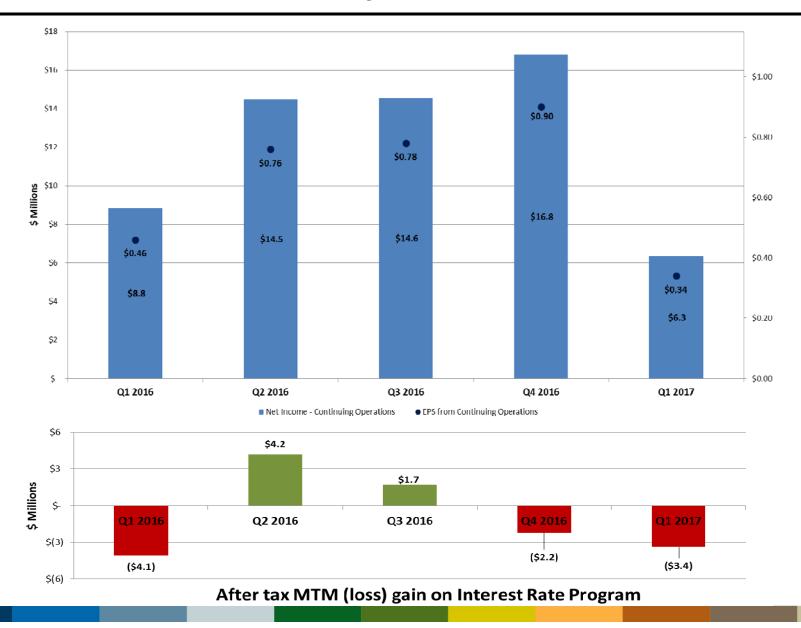

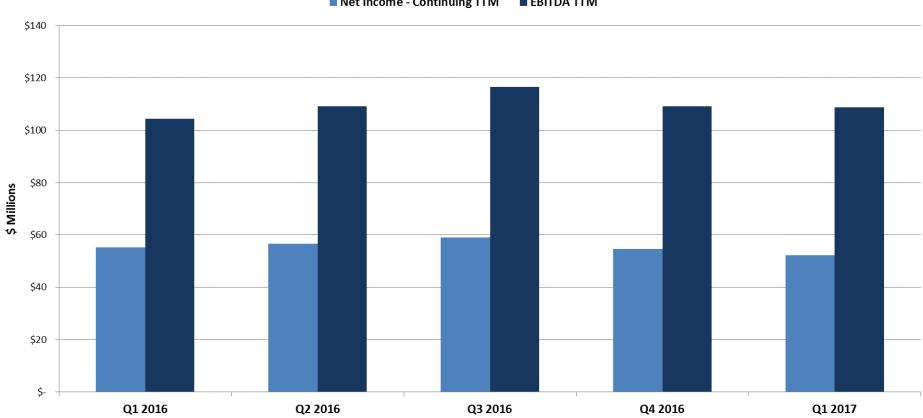


Quarterly Performance Trend
